EXAM INFORMATION

All exams cost \$60.00 and must be taken "in-person."

Any exam can be taken at an exam session. You can take more than one exam at an exam session; however, the exam session remains at three hours long.

The Stabilization Pond class deals strictly with ponds/ lagoons and is the best class for preparing to take the Small WW Exam. The Basic WW Treatment class deals with all types of wastewater treatment other than ponds/lagoons and is the best class for preparing to take the Class I WW Treatment exam. Small Systems that use ponds/lagoons for treatment can come into compliance with the Operator Certification Law by passing either the Small WW System exam or the Class I WW Treatment Exam. Water systems serving less than 500 individuals and use wells as its source can come into compliance by passing the Small Water Treatment exam. Larger systems must pass the Class I Water Treatment exam or higher depending on the facility classification.

- · Small Water System Operation and Maintenance





We couldn't have asked for better weather for the 2023 Rural Water Open. 204 golfers on 51 teams filled the greens at Elmwood Golf Course in Sioux Falls for the annual tournament. Each golfer was treated to a cooler bag filled with golf goodies and drink tickets. As golfers arrived for their tee times, they were also treated to Flyboy coffee and donuts courtesy of Hawkins.

Teams were sent out on the East, North, and West Nine every seven to eight minutes starting at 8:30 AM. The last teams hit the course at 10:37 AM. The WaterPac challenges returned this year, with On-The-Green-In-One-Shot challenges on both #8 East and West. This year also brought back the Pick-Your-Club Putt challenge. Participants chose a random card which told them what kind of club they'd need to make a six-foot putt. The options included a hockey stick, leak detector, whiffle ball bat, kid's plastic putter, and more. For an extra \$10 they could use their own putter. Mulligans were also available through presales and on the course. This year the Mulligans raised \$2,595 for WaterPac. The On-the-Green challenges raised \$2,340 and the putt challenge raised another \$790. All told, \$5,725 was raised for WaterPac, making this a record breaking WaterPac fundraiser for South Dakota Rural Water.

Following Rural Water Open traditions, theis tournament format includes a four-person teams playing an 18-hole scramble with no championship or amateur division. As always, an array of

talent was on display. Scores were competitive this year with the majority of teams posting scores below par. Scores ranged from 15 under to 12 over. Due to the nature of the dynamic field, scoring was based on score under or over par based on the particular 18 holes a team played. Also, tiebreakers were decided by hole handicap and final rulings were determined by the club professional, Chad Veire. The top placing teams are listed on page 18.

Box lunches consisting of a beef tenderloin sandwich, potato salad, a bag of chips, and a cookie were made available to each participant as they passed the clubhouse as they made the turn for their second nine holes. Each golfer was also provided with a tournament cooler bag filled with a sleeve of balls sponsored by Hawkins, bug spray, ball cleaner, sunblock, and two drink tickets provided by AE2S. Prizes were sent out to winners after the conclusion of the event.

BLOWING SMOKE

Some may say that Jeff Fossum has been blowing smoke or something close to that for many years now! The next question that is most likely coming to your mind is, "What this old Circuit Rider doing writing about or thinking that he can add new insight to this infiltration tool?"

In my past life (my job in the municipal world), the late Jerry Hemeyer from South Dakota Rural Water brought his blower and a box resembling TNT sticks with a fuse in one end. Being a younger worker with a good imagination, I thought about some of the old western movies and tv shows where you would throw the lighted sticks of dynamite over at the bad guys! Occasionally, the stick would have a short or fast fuse that would blow up, killing or maiming the good guy (me). Of course, I was wearing a white cowboy hat in this scenario. Then Jerry brought me back to reality and informed me that the TNT sticks were no more than a giant smoke bomb that would last about three minutes. We checked the area for smoke saturation while the smoke circulated through the sewer or storm sewer. The test would move to the next target area if Jerry felt the coverage was good. Or if he felt different, he would light one more stick until satisfied. This was a fun job until smoke would enter somebody's home through a dry drain or unglued plastic fitting. Jerry had often helped find the answer to sewer problems by blowing smoke. Once, our whole town was smoke tested to help find some big problems in the wastewater collection system. Another time Jerry came to our rescue was when an old, large public building had some smell and headache issues. After smoke testing the facility, it was found that the old cast iron soil pipe was cracked in multiple places. At a different time, an apartment house had a bad smell. The culprit was a floor drain hidden under the washing machine; it was a simple fix to add water to the drain.

I have gotten some field experience, and the equipment is about the same, but the smoke stick has been replaced by a gas-powered blower that uses the exhaust heat of its engine to heat a specialized liquid into a white harmless smoke. The best part of the machine that SDARWS owns is it is manufactured locally in Harrisburg, SD.

The number one problem in the field is cleanouts – either they are broken, or the cap is missing. One such place was in a flood zone. Can you imagine how much water can go down a pipe covered with a foot of water for how many days?

What I am trying to say with all of this is you never know when you will use the information taught to YOU today. A big shout out to my co-wastewater tech Danny Ayers; thank you for being such a great partner. Jerry Hemeyer, your knowledge and guidance is still being passed on from previous onsite smoke testing lessons.

EXERCISING THE VALVES IN YOUR WATER SYSTEM

one of the most important things an operator of a water system must have is control of that system. The valves in the system are an integral part of that control. When an operator has to isolate part of the system for any reason, if the valves they are using don't close fully or turn very hard, it makes for a long day for that operator.

Valve exercising is a preventative maintenance step that can be done periodically to help eliminate problem valves in your system. Exercising the valves ensures the proper function of the valve, and if flushing is done while exercising, it will also pull debris from the seat area of the valve so that the valve can close fully when needed.

South Dakota Association of Rural Water Systems has recently purchased a second valve exerciser. We will have one at our east river office and one at our west river office. SDARWS recommends that you exercise your valves every couple of years. Some of the systems that I have performed valve exercising at have waited longer than a couple of years, and when it came time to exercise them, many of the valves turned very hard. If it had been a severe situation where the valves needed to be turned quickly, they wouldn't have been able to do it.

Another part of the valve maintenance equation is ensuring the valve risers are clean. SDARWS has a hydro-vac at each office and can clean all the debris from the valve risers before exercising them. When a system calls us to exercise valves, we often have to make multiple trips because we find that the valve risers are full of debris and you can't get the valve wrench on the nut to operate the valve. We then have to get our hydro-

vac and clean them before we can exercise them.

Lead Service Line Inventory

What you (and your customers) need to know

To encourage your customers to complete the lead service line inventory, you'll need to understand the project and how to communicate about it. Luckily, there are messaging and communication tools already available for you.

Lead Service Line Requirements


The more "unknown" service lines you have, the more you'll have to replace, according to the Lead and Copper Rule.

Systems with lead service lines with compliance sampling results over **15 micrograms/liter** after corrosion control treatment installation must replace **7%** or more of the lead service lines in their distribution system per year—including lines marked as "unknown."



Initial inventory deadline: October 16, 2024



Requirements after the deadline: EPA

- Update every year or every three years based on the lead tap sampling frequency
- Systems that demonstrated absence of lead service lines by October 16, 2024, don't need to provide an update

Requirements after the deadline:

Customer follow-up

Provide notification to the persons served at the water connection with a LSL, GRR, or "lead status unknown" service line

- 30 days after completing the initial inventory; repeated annually until only non-lead service lines remain
- At time-of-service installation for new customers

Here are some suggestions you can consider communicating with your customers:

Your customer's service line has been identified to contain lead. What now?

- 1) We will be noting it in our inventory and designating it to be replaced in the near future.
- 2 In the interim, because your line has lead, you can flush your line. Use a NSF/ANSI 53 certified pitcher filter to protect yourself until the line is replaced.
- 3 Consider offering to collect a water quality sample from their service.




Rural Water EXPO | April 24-25, 2024





NEARLY \$1.2B SETTLEMENT WIN FOR WATER SYSTEMS AGAINST MANUFACTURERS OF PFAS

he National Rural Water Association (NRWA) is thrilled to announce a \$1.185B settlement has been reached in litigation against the manufacturers of perfluorooctanoic acid and perfluorooctane sulfonate ("PFAS"), including DuPont, Chemours, and Corteva. Napoli Shkolnik Law Firm,

NRWA's official partner, was a key player in the settlement that was announced earlier, which will help water systems affected by PFAS.

"We applaud the court, leadership of Paul Napoli, and the work of the Napoli Shkolnik Law Firm for recognizing the need for these companies to be held accountable," said John O'Connell, NRWA Board President. settlement is the beginning of helping our utility members in the fight against PFAS. We recognize there is still much work ahead to remove PFAS from rural areas."

While a settlement has been reached between these companies, the trial

against the remaining defendants, including 3M, is set for June 5, 2023, in Charleston, South Carolina.

NRWA has created the PFAS Cost Recovery Program to help systems with PFAS treatment costs. If your system has already signed up for the program, Napoli will be in contact with you with next steps, which may involve more testing. If your system has not registered for the program, we encourage you to contact Napoli Shkolnik PLLC to represent your system as a trusted attorney who will fight for compensation to overcome the financial impacts of PFAS. NRWA has retained the firm to represent the Association and our members.

NRWA LEADERSHIP AND LITIGATION

NRWA's leadership had the foresight to see and understand that PFAS, including the monitoring of levels, treatment, and remediation costs, would be a major issue for rural water and wastewater utilities. Early in 2018, NRWA partnered with

> Napoli Shkolnik PLLC to file a lawsuit on behalf of its members.

> "It is great to see the board's vision start to come to fruition," said Matthew Holmes, NRWA Chief Executive Officer. "We hope this settlement will benefit our members and rural systems across the country for many years to come as they continue to test and treat PFAS in our nation's drinking water."

CONCLUSION

NRWA and its 50 State Rural Water Associations have been representing the needs and concerns of small and rural utilities as we navigate the challenges created by PFAS. NRWA acknowledges that Water Professionals are the backbone of

small and rural communities, providing safe drinking water and clean wastewater treatment while supporting economic growth and protecting public health.


