





Me knowing of the equipment that is owned by SDARWS he was able to come to my rescue. We are presently working on a street project (curb & gutter, storm drain, concrete paving, and sidewalks). A lot of the town is under construction, and the unforeseen always happens. At one of the intersections, we found a main valve that was inoperable. Two people with 6-foot cheaters could NOT operate the valve. I got in touch with Brant, and he was able to come to Murdo with the hydraulic valve operator that is on the Kubota side by side. I was amazed at the operation of this equipment. With the street project and not having to dig and replace a valve repair clamps and not having to do with any change orders with the contractors the savings estimated at \$4,000 to \$5,000.

With all that being said HATS OFF TO Brant Ager, he came through with flying colors.

"Their newly re-designed website features an interactive map of rural water systems, online class and event registration, digital magazines, services and fees, live Facebook and Twitter feeds, as well as history, staff contacts, and promote NRWA Affinity Programs."


SDARWS is the only Rural Water Association in the nation who produces a consumer magazine. "Quality on Tap!" is published quarterly along with 17 participating Rural Water Systems, and is created in-house. 34,000 copies are mailed quarterly, and reach about half of our rural water consumers in South Dakota. "QOT" highlights water issues affecting consumers, and proves successful in creating a unified voice for rural water in our state. Other publications produced by SDARWS include ServiceLine magazine, Rural Water Bi-Monthly eNews, JobConnection eNewsletter, and Ripples Legislative eNewsletter.

SDARWS' public relations efforts are administered by our Communications and Marketing Coordinator Jennifer Bame. Jennifer is a graduate of South Dakota State University, with a B.A. in Journalism/Mass Communications, and has been with SDARWS since 2012. The Association also received this award in 2016, and was awarded State Association of the Year in 2017.

The 2018 WaterPro Conference was held September 17-19 in Fort Worth, Texas. The opening included speeches from NRWA President Steve Fletcher, Assistant to the Secretary for Rural Development at the United States Department of Agriculture Anne Hazlett, and NRWA CEO Sam Wade.

56 South Dakotans traveled to WaterPro and were treated to educational sessions on new water technologies, operations and management, and an exhibit hall full of useful tools and services. 



DEFINE FLUSHABLE

he items found in a wastewater system vary widely. Items vary by town, region, and even by state.

Coins, watches, shoes, bed sheets, toys, clothes, and rings are just a few of the items that have been found in a wastewater collection system. The only commonality is that most of the items are not actually "flushable"...

Now the rule of thumb is: if it has not been eaten or cannot be eaten, it should not go down the drain. The main exception to that rule is, of course, toilet paper. If you ask any wastewater system operator South Dakota, "What is the worst thing you find in your system?" Invariably, the answer will be "Flushable wipes." The flushable wipe is a personal hygiene cloth that is deemed on the package as "flushable." It may say flushable, but the item is, however, not biodegradable. Therein lies the problem in a wastewater collection system, most "normal"

material is biodegradable or also known as organics. Items that are inorganics may include sand, grit, and minerals that can be dealt with mechanically in a wastewater system. Personal wipes do not break down and are of a material that resists being torn or cut and tends to plug or bind mechanical apparatuses. Wastewater systems have spent many thousands of dollars in dealing with personal wipes. Countless hours are spent clearing lift stations, pumps, baskets, screens, and blockages all due to issues with personal wipes. Pump repair or replacement is not an inexpensive budget item, especially when the pumps life expectancy is shortened exponentially.

One town is upgrading and rebuilding a lift station specifically to deal with the personal wipe problem. To save on repair costs and equipment failures, they have decided to put in a bar screen that will catch the personal wipes and other items not wanted in a wastewater system and remove them to a garbage dumpster before damage can occur to the pumps and valves. The system is being installed now, and as more info becomes available, it will be included in the next few articles. Stay tuned, as they say, for the rest of the story...

WATER SYSTEM TAMPERING

veryone sees the signs that are hanging on fences around water plants and pump stations that state tampering with a water system is a federal offense. Most people probably look at them and think that it is just a scare tactic used by the water system to try to keep people away from their facilities. The truth of the matter is that tampering or even planning to tamper with a water system is, in fact, a federal offense that falls under statute 42 U. S. C. 300i – 1. The penalty for such actions is 20 years (10 if attempt or threat) and/or fines pursuant to 18 U. S. C. 3571.

Most of you reading this may be asking why I would be writing an article about this? The answer started a while back when I received a phone call from a water system on a Sunday morning about a leak they had in their system and may need my assistance finding it. I told the system that I would be available to assist them and to let me know if they needed me to come out and help. The manager for the system said they would try to track it down themselves first but ask that I keep my phone near me just in case. A few hours went by, and the manager called me back and had told me that they had started to isolate portions of the system

to try and figure out what area the leak would be in and had come across five of their mainline isolation valves that the bottom of the valve riser had been filled with concrete. I asked the manager if he had a contractor on the way because the only way to find the leak was to get those valves in working order. The manager said he did and just wanted to keep me up to date with what was going on if I had to assist them. More time had passed, and it was late afternoon, and the manager called me back again and said that a rancher had found the leak in his alfalfa field and they were in the process of getting the line shut down to do the repair. He thanked me for being available.

The next morning on my way to work I received a call from the manager again and asked me to stop by and see him and that he had something to show me. I told him I would, and when I arrived, I was shocked at what I saw. Along with the five valve risers with concrete, possibly the same person, had taken a steel fence post and removed what I call the spade portion of it, turned it around, so the two points were facing down and welded it back on to the post. The person then took the post and drove it into the ground until it penetrated the PVC water line creating the leak. The estimated water loss was 350,000 gallons not to mention the cost of excavating the leak and the five valve risers that needed to be fixed. The local sheriff's department was called in and the Region 8 EPA special investigation team was also made aware of the happenings.

In the end, the warning signs that are put on fences that state tampering or planning to tamper with a water system is a federal offense is stating the truth and not just a scare tactic. If you see someone doing such a thing help your water system out and let the authorities know. It will save everyone added costs.





outh Dakota Association of Rural Water Systems (SDARWS) is pleased to announce the hiring of Abbey Larson as the new Wastewater Technician II. The new position will be stationed in our west river office in Spearfish, SD. Abbey has already found living quarters in Spearfish and has begun settling into her new home. Abbey has a B.S. Degree in Civil Engineering from the South Dakota School of Mines and Technology. She had been working for South Dakota Department of Environment & Natural Resources as a "Natural Resources Engineer I" in Pierre, SD. Abbey's first day with SDARWS was Monday, October 1, 2018. Following a day of introductions and paperwork, she spent a good share of her first week with SDARWS's other Wastewater Technician, Bill Thorson for orientation and work scheduling.

SDARWS received the news on July 2, 2018 that our Association would be receiving a new Wastewater Technical Assistance & Training (TAT) position. National Rural Water Association (NRWA) contacted Executive Director Pfeifle and followed up with an email stating that the NRWA Executive Committee approved budget adjustments and expansion of positions for the USDA Wastewater and Energy Efficiency programs. Overall 14 new positions were created nationwide, including seven wastewater technicians and seven Energy Efficiency positions:

- Seven positions were added to the USDA Wastewater Training & Technical Assistance program: MT, OR, KS, CO, SD, AZ, VA
- Seven positions were added to the USDA Energy Efficiency program:

FL, IL, WI, IN, PA, MN, NC

The new Wastewater Technician position will be funded through USDA – Rural Development, through a subaward contract with NRWA. The new position comes to SDARWS with a Program allocation of \$115,000 per year. The allocation provides direct funding for salary, benefits, travel, training materials and funding for certain indirect costs (share of expenses that keep the business running) to SDARWS.


